## **Safety Rules**

### **General**

- 1. Failure to follow Delta's **health & safety rules**, policies and procedures will result in removal from the site and may result in Delta terminating the contract.
- 2. **Smoking** is only permitted in the designated smoking area, located outside.
- 3. The possession, storage, sale or consumption of **alcohol or illegal drugs** on Delta property, or while working for Delta, is strictly prohibited and will result in the immediate removal from the site.
- 4. **Theft, wilful destruction of property, fighting, threatening or abusive behaviour** against any person will result in the removal from the site and/or prosecution.
- 5. Food and beverages are only allowed in permitted areas.
- 6. **Cleaning up** the work area is considered part of the job. Failure to do so may result in payment being withheld from the contractor until the job is complete and/or a back charge to the contracting firm for the clean up.
- 7. Contractors require safety and operational **training** for the work and equipment they operate. Working at heights, operating lifting devices, confined space entry, lockout, hot work, welding, working with chemicals are examples of some tasks that require safety training.
- 8. All accidents must be immediately reported to your Delta contact.
- 9. This policy and all Delta Health & Safety policies apply to all contractors, their employees, and their **subcontractors**.

## **Manufacturing**

- <u>Safety glasses and safety footwear is required in the Manufacturing area.</u> Additional **Personal Protective Equipment** may be required to safely perform a task. Failure to wear proper personal
   protective equipment may result in the Contractor's removal from the site and Delta may decide
   to terminate the contract.
- 2. <u>The laser cutter emits hazardous radiation. Check with the laser cutter operator prior to</u> <u>performing any elevated work in the Manufacturing area to schedule elevated work when the</u> <u>laser is not operating. Keys to the scissor lift are held by the laser cutter operator.</u>
